RULES

* 31,210 tickets available at \$100 each and 7,540 packages of three tickets for \$250 and 890 packages of five tickets for \$375 and 3,590 packages of eight tickets for \$500 for a total of 87,000 tickets.

$$\{(31,210 + (7,540 \times 3) + (890 \times 5) + (3,590 \times 8)\} = 87,000\}$$

* Persons must be 18 years of age to purchase a ticket and the name of a person under 18 years of age may not be written on the ticket due to requirements of the Public Trustee Act.

* All ticket purchases are final; refunds are not available.

* 2,530 prizes will be awarded. All prizes awarded are new product.

The VIP ticket sales deadline is midnight, **August 30, 2019**

The Bonus Draw is **October 2, 2019**

The Bonus ticket sales deadline is midnight, **September 27, 2019**

The Final Draw Date is **December 4, 2019**

The Final ticket sales deadline is midnight, **November 22, 2019**

TICKETS SOLD BY THE VIP DEADLINE:

All tickets sold by midnight, August 30, 2019 will be eligible for the VIP draws on September 12, 2019. The draws will commence at 8:30 am at the offices of Deloitte located at 1500 Manulife Place, 10180 101 St. NW, Edmonton AB, T5J 3S4.

TICKETS SOLD BY THE BONUS DEADLINE: All tickets sold by midnight, September 27, 2019, will be eligible for the Bonus draw on October 2, 2019. The draw will commence at 1:00 p.m. at the offices of Deloitte LLP, located at 1500, 10180-101 Street NW, Edmonton, AB T5J 3S4.

IF ALL TICKETS ARE SOLD BY THE EARLY BIRD SALES DEADLINE: In the event that all tickets are sold by the Early Bird deadline of midnight, November 1, 2019, then all draws will be held November 12-13, 2019, commencing at 8:30 a.m. at the offices of Deloitte LLP, located at 1500, 10180-101 Street NW, Edmonton, AB T5J 3S4.

The first draw will be for the Early Bird Prize, which will be followed by 2,523 preliminary draws, drawn in order of retail value beginning with the prizes of least retail value. The top four prizes will be announced on *Global News Morning* on November 14, 2019 between 6:00 am and 9:00 am.

IF ALL TICKETS ARE NOT SOLD PRIOR TO THE EARLY BIRD SALES DEADLINE: In the event that tickets remain after the Early Bird deadline, then only the Early Bird draw will take place on November 13, 2019. The Early Bird draw would take place at

the offices of Deloitte LLP located at 1500, 10180-101 Street NW, Edmonton. The Early Bird draw will commence at 8:30 am. Ticket sales would continue until the Final sales deadline of midnight, November 22, 2019. All draws would be held December 3-4, 2019, commencing daily at 8:30 am, at the offices of Deloitte LLP located at 1500, 10180-101 Street NW, Edmonton. The 2,523 draws would proceed and be drawn in order of retail value beginning with prizes of least retail value. The top four valued prizes will be announced on December 5, 2019 on *Global News Morning* between 6:00 am and 9:00 am.

After each draw, including the VIP, Bonus and Early Bird draws, the winner is recorded, and the ticket number goes back into the draw drum for the next draw. All tickets purchased prior to the VIP deadline will be eligible for all 2,530 draws. Each ticket purchased after the VIP deadline, but before the Bonus deadline will be eligible for 2,525 draws. Tickets purchased after the Bonus deadline, but before the Early Bird deadline will be eligible for 2,524 draws. Tickets purchased after the Early Bird Deadline will be eligible for the remaining 2,523 draws.

All winners of prizes will be notified in writing by Deloitte LLP as to what they have won and how to claim their prize. A list of winners will be published online at MightyMillionsLottery.com on November 20 or December 11.

Draw information will be well advertised on the lottery website, official ticket and in the lottery brochure. This schedule leaves adequate time to process all ticket applications and ensure the database of ticket holders is complete and accurate.

* All winners of prizes will be notified in writing by the accounting firm of Deloitte as to what they have won and where and how to claim their prize.

* All prizes must be accepted as awarded with no cash equivalencies available.

* All draws will be made as stated. An extension of draw dates or cancellation of raffle would only be requested from the Alberta Gaming and Liquor Commission in the unlikely event of a natural disaster or catastrophic event

* Draw Order: The first draws are for the VIP Prizes, the sixth draw is for the Bonus Prize, the seventh draw will be for the Early Bird prize. Thereafter, draws are made in order of retail value beginning with the prizes of lowest retail value. After each draw, the winner's name and ticket number is recorded and the token is returned to the draw drum.

* In the event that multiple tokens are inadvertently pulled from the draw drum, and this is not identified prior to identifying and reading of the token number, the token number read aloud, confirmed and recorded is deemed to be the first token pulled and therefore established as the valid winner.

* A draw will only be deemed valid and complete upon final confirmation and recording by Deloitte LLP.
